#### 2020 Budget

CAO/Treasurer Cathy Case advised Council that a 0% municipal tax rate increase would raise an additional \$283,735.59 in taxes over 2019 based on the 2020 assessment roll as returned.

CAO/Treasurer Cathy Case presented Council with the 2020 proposed reserves, and the unaudited 2019 reserves listing, and noted that \$833,000 is forecasted to be transferred out of the 2019 reserves listing to help offset the 2020 budget.

# **Capital Projects**

## Fire 2020 Budget

Fire Chief Arend Noordhof spoke to the purchase of a rescue van/truck for the fire department.

MOVED by Councillor MacKinnon SECONDED by Deputy Mayor Hendrikx

Resolved that Council approve the 2020 Fire Department budget line item of \$375,000.00 for a new capital purchase of a rescue van/truck and that Council direct staff to proceed with the Request for Proposal. CARRIED.

CAO/Treasurer Cathy Case presented Council with a spreadsheet outlining a ten (10) year capital forecast for the replacement of Township vehicles and equipment.

Council discussed the installation of sidewalks throughout the Township and discussed the implementation of a plan and the amount to be included in the 2020 Budget. The areas included:

- Napperton Drive, North East
- Pike Road, North East
- Napperton Drive, North West

MOVED by Councillor Clarke SECONDED by Councillor Brodie Resolved that Council approve the grants listing for the 2020 Budget as applied for. CARRIED. Mayor Smith asked each department head if there were any areas within their budget, where any item could be removed from the 2020 budget, and be incorporated to a future budget.
