THE CORPORATION OF THE TOWNSHIP OF ADELAIDE METCALFE

BY-LAW #35-2009

Being a By-Law of the Municipal Corporation of the Township of Adelaide Metcalfe to implement a program of Waste Reduction and Waste Management in the Township of Adelaide Metcalfe together with tipping and "user pay" fees.

WHEREAS the goal of the Township of Adelaide Metcalfe is to reduce waste through various public initiatives and thus minimize the environmental impact of waste disposal.

AND WHEREAS the aim is to use the landfills in a sustainable manner in order to extend the life of the facilities as long as possible for the use of the residents of the Township of Adelaide Metcalfe.

NOW THEREFORE BE IT ENACTED AS FOLLOWS:

A. LOCATION AND HOURS OF OPERATION

- 1. The Landfill Sites are located at 29349 School Road and 27200 Kellam Road.
- 2. The Landfill Site located at 29349 School Road will be open the first Saturday of every month between the hours of 8:00 A.M. and 4:00 P.M.
- 3. The Landfill Site located at 27200 Kellam Road will be open the last Saturday of every month between the hours of 8:00 A.M. and 4:00 P.M. The landfill site will be closed for the months of January and February of each year.

A. GARBAGE DISPOSAL

- 1. Disposal at the Township of Adelaide Metcalfe Landfill Sites is restricted to that material that originates in the Township of Adelaide Metcalfe.
- 2. Effective November 16, 2009, tipping fees are payable as set out in Schedule "A" attached hereto and forming part of this By-Law.
- 3. The following materials will not be accepted at the landfill sites:
 - > Blue box recyclable materials unless tagged
 - > Compostable material
 - > Commercial vegetable waste
 - > Automobile bodies
 - Dead livestock or poultry
 - Cardboard
 - ➢ Garden waste
 - > Asphalt
 - > Hazardous waste
 - > Asphalt shingles
 - Railway ties
 - Any other material as may be deemed unacceptable by the Council of the Township of Adelaide Metcalfe
- 4. The following will be allowed in designated areas:
 - ➤ Wood (brush and used lumber)
 - ➤ Bricks, concrete blocks, broken concrete, small quantities only of rocks and stones, metal (including fence wire that is free of wooden posts)
 - > Tires

C. REGULAR CO-COLLECTION

- 1. Effective November 16, 2009, all garbage bags or containers must be tagged. Tags can be purchased at the Municipal Office for \$2.00 each. A list of retailers that sell tags is available at the Municipal Office.
- 2. Only employees of the Bluewater Recycling Association may remove material from the blue boxes that have been set out for roadside co-collection.

D. PENALTIES

1. Any individual or corporation found guilty of contravention of any section of this By-Law shall be fined on summary conviction up to \$2,000.00

E. EFFECTIVE DATE

1. This By-Law shall come into force on the 16th day of November, 2009.

TIPPING FEES FOR DUMPING AT THE LANDFILL SITES

\$15.00 Pick up truck load or equivalent for non recyclable materials No charge for freezers, refrigerators, air conditions, dehumidifiers that are tagged with an O.D.P. sticker \$15.00 Appliances not tagged with an O.D.P. sticker \$ 6.00 per item Carpet, televisions, stereos, mattresses, linoleum, etc. garbage bag or equivalent for machine shop/tool \$ 2.00 & die waste (metal shavings) Household garbage bagged and tagged up to a maximum \$ 2.00 per bag of 45 pounds Other volumes at the discretion of the landfill supervisors These prices come into effect with the final passing
