**BY-LAW #45-2014**

**BEING A BY-LAW TO ESTABLISH VARIOUS AND CHARGES FOR THE SERVICES PROVIDED BY THE CORPORATION OF THE TOWNSHIP OF ADELAIDE METCALFE**

**WHEREAS** pursuant to the authority granted in the various Acts of the Ontario Legislature, including The Municipal Act, The Planning Act and the Municipal Tax Sales Act, the Council of the Corporation of the Township of Adelaide Metcalfe may pass by-laws for the setting of user fees and charges;

**AND WHEREAS** the Council of the Corporation of the Township of Adelaide Metcalfe deems it expedient and desirable to set user fees and charges for the services as provided by the Township;

**AND WHEREAS** the Council of the Corporation of the Township of Adelaide Metcalfe deems it expedient to amalgamate the fees and charges as authorized by this By-Law and by other by-laws enacted by the Council of the Corporation of the Township of Adelaide Metcalfe.

**NOW THEREFORE** the Corporation of the Township of Adelaide Metcalfe


**ENACTS AS FOLLOWS:**

1. That Schedule "A" attached hereto and forming part of this By-Law sets out rates and fees and charges for those matters contained with the schedule for this By-Law.
2. That any rates and fees and charges inconsistent with this By-Law shall be deemed to be repealed and replaced with the provisions of this By-Law.
3. By-Law No. 70-2011 and all amendments thereto not consistent with this By-Law are hereby repealed.
